Approval of Minutes

The minutes from the February 27, 2023, Board of Directors open session meeting were provided via Office of Investments website. The Chair asked for a motion to approve the minutes. PIMCO Market Update

Kristen DePre and Kevin Brooks provided an overview of PIMCO Income Fund, strategy, and a market update. The information can be found in the meeting presentation materials. The discussion was on PIMCO's strategy to navigate the Debt Ceiling talks and its potential impact on Treasury bills that matured during the "X" date. Based on historical debt ceiling negotiations, PIMCO's base case is that the Debt Ceiling deal will get done prior to that date.

Fund Performance updates can be found in the meeting presentation materials. Liquidity concerns were addressed and private asset continuation fund opportunities. Mr. King stated that they had two situations like this, and the decision was made to monetize those assets. Mr. King addressed questions on first quarter valuations. He stated that half of the evaluations had been received and the Fund's private equity is net positive. Mr. King also stated that the Fund's cryptocurrency exposure is minimal. The May 17, 2023 UNCMC Member Update experienced internet issues. The meeting will be rerecorded, and the link will be provided to the board members and participants.
